



Green30 Challenge Rebate Application

Take the Green30 Challenge! By downsizing to a green 30-gallon trash cart and taking a composting class you may qualify for a rebate on a home composter. As part of Austin's Zero Waste goal to reduce the amount of waste Austinites send to the landfill by 90% by the year 2040, **rebates of 75%* of the value of a purchased home composter** are being offered to Solid Waste Services residential customers. Rebates will be granted for purchases made after the eligible period which began April 22, 2010.

*The value of the rebate is 75% of the total cost of a home composter or home composting system with a maximum value of \$75. Therefore, any composters or home composting systems that cost more than \$100 will receive a rebate of \$75. Claims can only be made on home composters or home composting systems. Homemade composters do not qualify. See Full Terms and Conditions of the Green30 Challenge (page 2) for details.

Full Terms and Conditions

These terms and conditions apply beginning April 22, 2010

- 1) The applicant must be a City of Austin (COA) Solid Waste Services (SWS) Residential Collection Customer.
- 2) The applicant must agree to the Full Terms and Conditions of the Green30 Challenge as described by COA SWS, which include completing a basic composting class coordinated by COA SWS and downsizing to a 30-gallon green trash cart.
- 3) The applicant must complete this application form and mail it to COA SWS (contact details provided on page 1) along with the relevant receipts from purchases and any other specified information set out on this form.
- 4) Receipts must be dated after April 22, 2010. Receipts submitted for eligible purchases must be a copy of original receipt or invoice.
- 5) Taxes or delivery charges can not be rebated as part of the total purchase price.
- 6) Only one (1) rebate per eligible household.
- 7) The value of the rebate is 75% of the cost of a home composter or home composting system with a maximum value of \$75.
- 8) Rebates can only apply to home composters and home composting systems.
- 9) Homemade composters DO NOT qualify.
- 10) Funding is limited and rebates are available on a first-come, first-served basis.
- 11) Rebate recipients must cooperate with City staff research regarding the home composting products purchased and how they are being used.
- 12) Rebate recipients must repay any rebate provided, if any part of the Terms and Conditions is found to have been breached.
- 13) COA reserves the right, at its sole discretion and at any time, to change any or all of the Terms and Conditions for the Green30 Challenge or to cancel the Green30 Challenge.
- 14) The applicant(s) acknowledges and agrees that as far as the law permits, the COA accepts no liability in respect to claims, causes of action or loss or damage arising out of or in relation to any of the products subject to this rebate program. The applicant(s) agrees that they will indemnify and keep indemnified the COA from any claim or liability arising out of or in relation to any of the products subject to this rebate program.
